#### AIPG


The geologists in Marion's consulting Department have secured professional licensure in the states of Tennessee, Georgia, Alabama, North Carolina, South Carolina, Kentucky, Virginia and Texas. These licenses enable MEI to provide environmental consulting services to clients throughout the southeast region in addition to serving locally.

Rusty Sewell, one of Marion's senior geologists, currently serves as the president of the Tennessee Section of the American Institute of Professional Geologists (AIPG). AIPG is an advocate for the geology profession and communicates regularly to federal and state legislators and agencies on matters pertaining to the geosciences. Currently, there are about 7,800 active members of AIPG. On September 10<sup>th</sup>, Rusty presented the Tennessee Section's annual report to the AIPG Executive Committee at their 2016 Annual Meeting held in Santa Fe, New Mexico.

In addition to the section report presentations, the meeting included discussions associated with possible changes to professional licensure programs in various states, including movements to eliminate state license requirements.

Four Advisory Board Representatives were also elected to serve on the National Executive Committee. Rusty was elected by his colleagues to serve as an Advisory Board Representative on the National Executive Committee for 2017.

As an Advisory Board Representative, Rusty will attend three Executive Committee meetings where the affairs of the Institute will be managed.
